POLS 480. FIELD RESEARCH WORKSHOP

Instructor: Emre Erdoğan, Assoc. Prof.

Objective:

This course aims to give participants the capability of designing and conducting survey research.

Participants will learn about thinking processes of human beings, history of polling, designing

sampling frameworks, developing and testing questionnaires. A fieldwork will be held by using

questionnaires developed by participants.

Assignments:

The course is highly dependent to class participation, by reading and criticizing assignments. Each

student is expected to complete readings and participate to class discussions. In addition to this

"normal" assignment; there are some formal assignments:

1. According to number of participants and topics to be covered, students are expected to form

Workgroups, to make literature reviews, prepare presentations about the state of discipline and

propose and develop questions about their issue;

2. Each participant has to conduct in-depth and pilot interviews;

3. Each participant has to conduct a minimum number of interviews with the final questionnaire

in selected neighborhoods and prepare reports about these interviews;

4. At the end of term, a take home exam will be given;
